This course constitutes a fascinating intersection between economics and politics with focus on the EU relationship with the Arab world. From the development of new borders in the aftermath of World War I to the decolonization processes and the Cold War in the aftermath of World War II, the Middle East has been in the epicenter of political and economic developments on the European continent. The emergence of the European Union as the institutional continuation of the European Economic Community in 1992 has provided a unique framework for the discussion and resolution of major policy challenges that have been endemic in the Arab region.

The part of the course taught by Prof. Niedermeier focuses on EU foreign policy and economic diplomacy in the Arab world, while looking at the domestic politics of key Arab states and their

related interaction with major European economies. The part of the course taught by Prof. Grigoriadis will concentrate on a series of EU-MENA policy themes such as trade and growth, development aid, energy, climate change, and international security (including Russia`s ongoing war in Ukraine).
